<b>Civil Deputy Time (Standby, Eviction)</b>	\$125 per hour
<b><u>Eviction Related-</u></b> <b>Writ of Recovery, Eviction Summons &amp; Eviction Action Complaint</b> Posting Service Fee Lockout/Eviction	\$80 \$80 1 <sup>st</sup> person, \$10 each additional service \$125 per hour
<b><u>Mortgage Foreclosure-</u></b> Service Fee per person—3 attempts Each additional attempt at same address Judgment & Decree Posting 3 places (ACSO, Anoka County Courthouse, City Hall of City in which home is located) Conducting Sale Outside Bidder Fee (for winning bidder)	\$80 \$30 \$80 \$80 \$100

<b><u>Commission on Executions</u></b> <i>(Based on gross amount collected, seized, or stipulated to by parties or any settlement resulting from ANY action of the Anoka County Sheriff's Office to satisfy the Writ of Execution or Sheriff's Levy or hourly deputy time spent on the collection efforts, whichever amount is of greater value.)</i>	5%
<b><u>Storage Fee</u></b> <i>For vehicles maintained by the Sheriff's Office while awaiting Sheriff Sale for Writs of Execution or other Civil Matters</i>	\$20
<b>Execution Sales &amp; Sheriff's Sales/Lien Sales</b>	\$200**
<b><u>Redemptions</u></b> <b>Record Redemption Documents for Junior Lienholders</b> <i>(Lien Holders, Judgment Holders, Intent to Redeem)</i> <i>Non- Sheriff Redemption</i>	\$250 \$100 \$20
<b>Replevins, Attachments or Seizures</b>	\$200**
<b>Replacement Certificate of Service (ink signature)</b>	\$10
