Civil Deputy Time (Standby, Eviction)	\$125 per hour
<u>Eviction Related-</u> Eviction Summons & Eviction Action Complaint Personal Service Posting Fee Writ of Recovery Service or posting of Writ and 24-hour Notice. Includes deputy time for eviction/lockout up to 60 minutes.	\$100 1 st person, \$10 per additional person served \$100 if unable to personally serve \$180 Additional time billed at \$125/hour

<u>Commission on Executions</u> <i>(Based on gross amount collected, seized, or stipulated to by parties or any settlement resulting from ANY action of the Anoka County Sheriff's Office to satisfy the Writ of Execution or Sheriff's Levy or hourly deputy time spent on the collection efforts, whichever amount is of greater value.)</i>	5%
<u>Storage Fee</u> <i>For vehicles maintained by the Sheriff's Office while awaiting Sheriff Sale for Writs of Execution or other Civil Matters</i>	\$20
Execution Sales & Sheriff's Sales/Lien Sales	\$200**
<u>Redemptions</u> Record Redemption Documents for Junior Lienholders <i>(Lien Holders, Judgment Holders, Intent to Redeem)</i> Non- Sheriff Redemption	\$250 \$100 \$20
Replevins, Attachments or Seizures	\$200**
Replacement Certificate of Service (ink signature)	\$10
